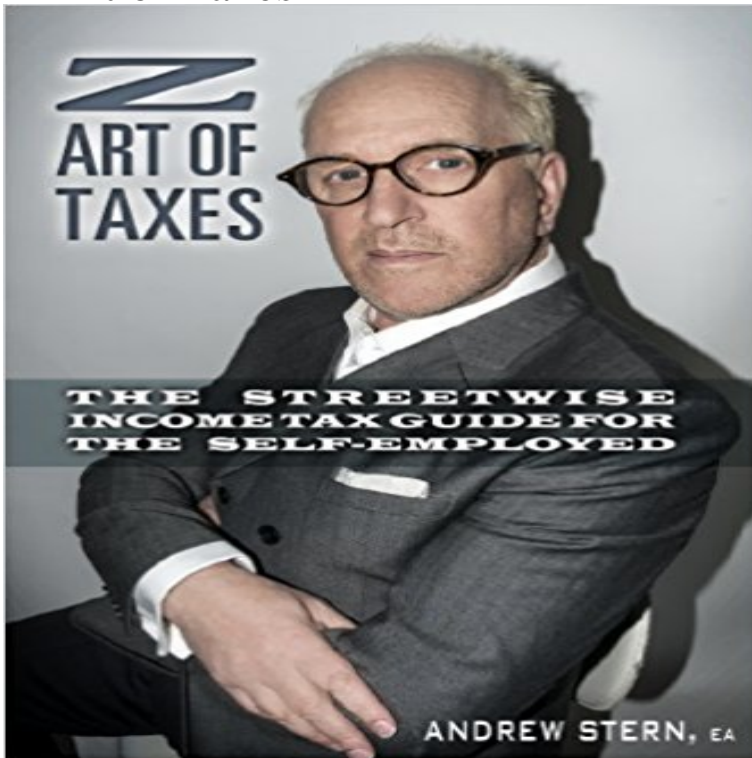


## Z Art of Taxes

Bottom line, taxes cannot be ignored. We all have to prepare and file tax returns and pay taxes every single year.
