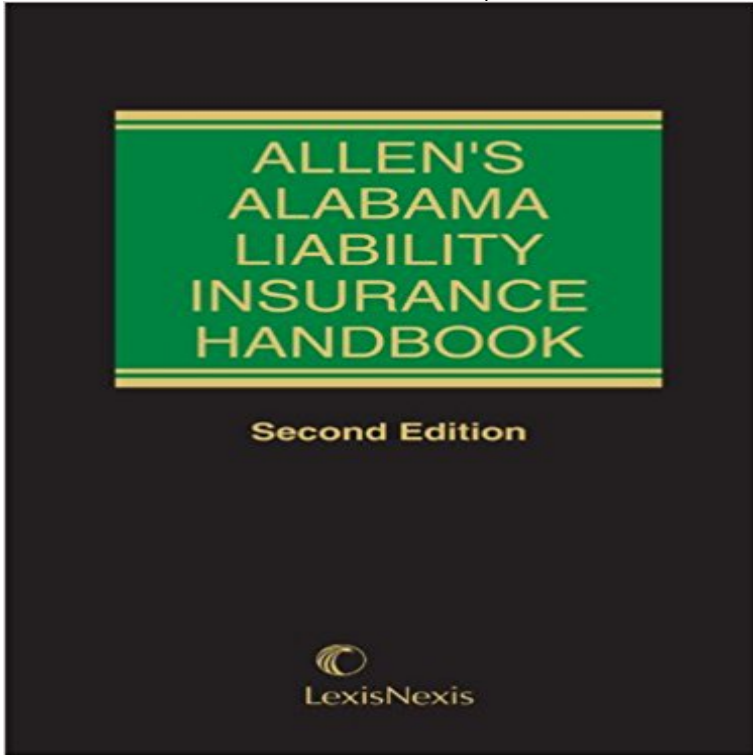


# Allens Alabama Liability Insurance Handbook
