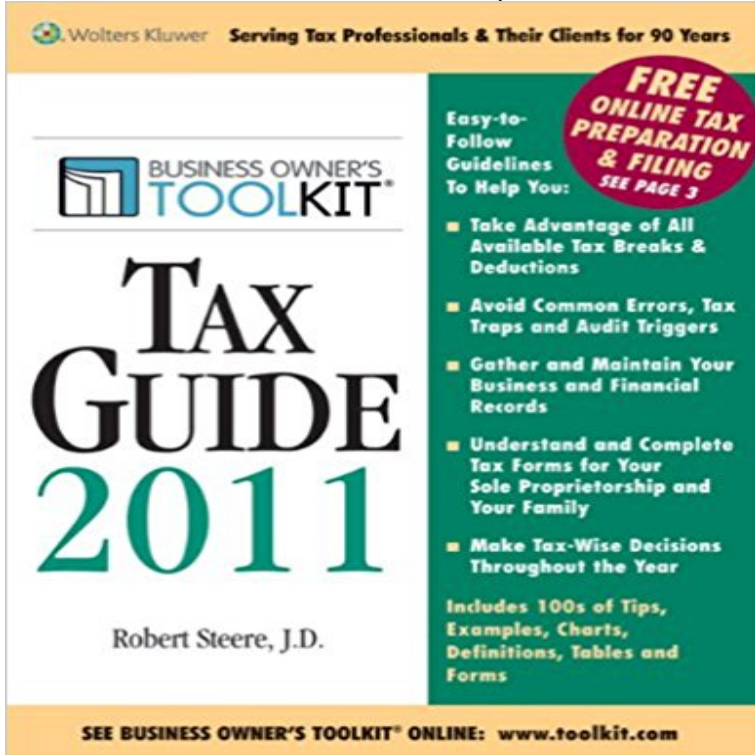


# Toolkit Tax Guide 2011 (Business Owners Toolkit series)
