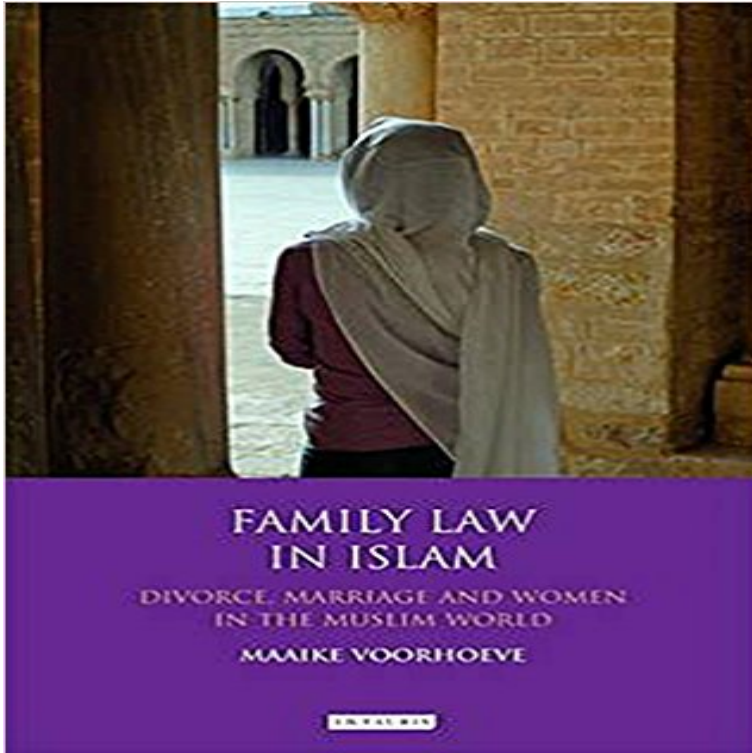


Family Law in Islam: Divorce, Marriage and Women in the Muslim World

Using a range of contemporary examples, from polygamy to informal marriage (zawaj urfi), and from divorce with mutual agreement (khul) to judicial divorce (tatliq), this wide-ranging and penetrating volume explores the impact of Islamic law on individuals, families and society alike from Morocco to Egypt and from Syria to Iran. It thus contains material of vital importance for researchers of Islamic Law, Politics and Society in the Middle East and North Africa.
