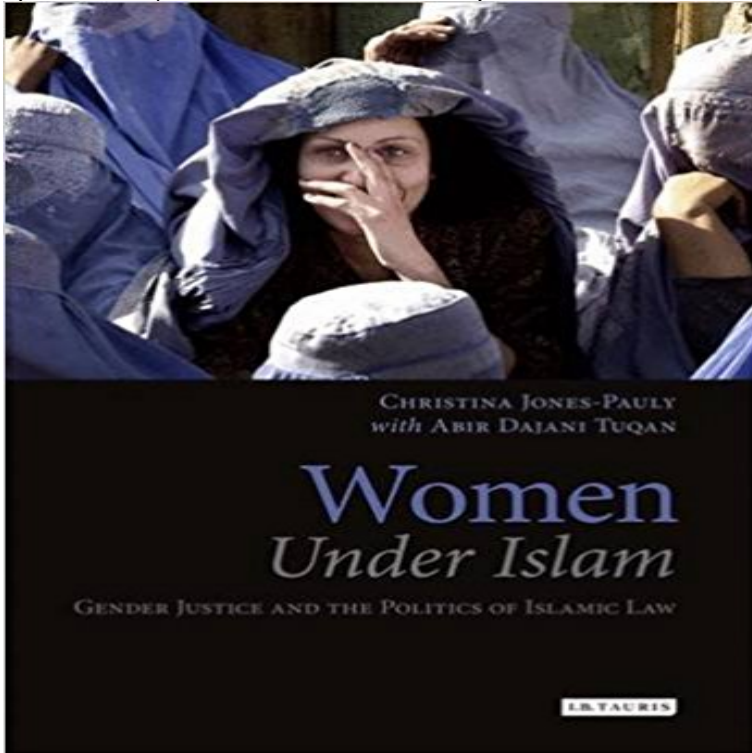


## Women Under Islam: Gender, Justice and the Politics of Islamic Law (Library of Islamic Law)
