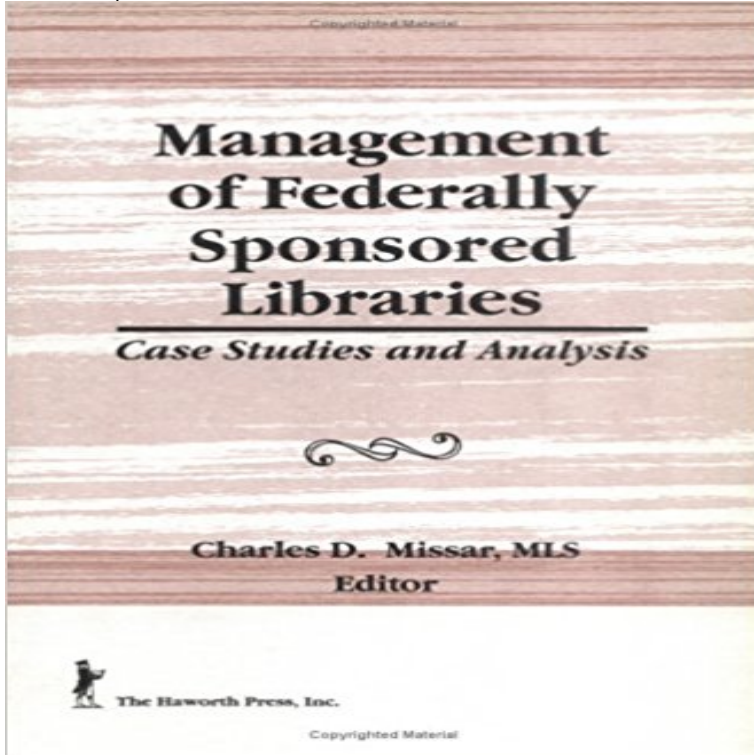


# Management of Federally Sponsored Libraries: Case Studies and Analysis
