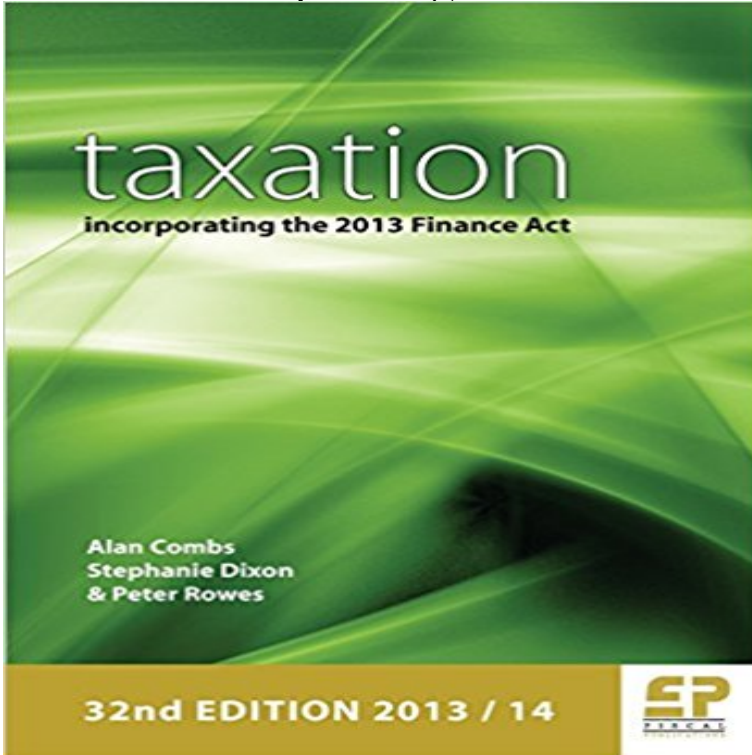


Taxation Incorporating the 2013 Finance ACT
