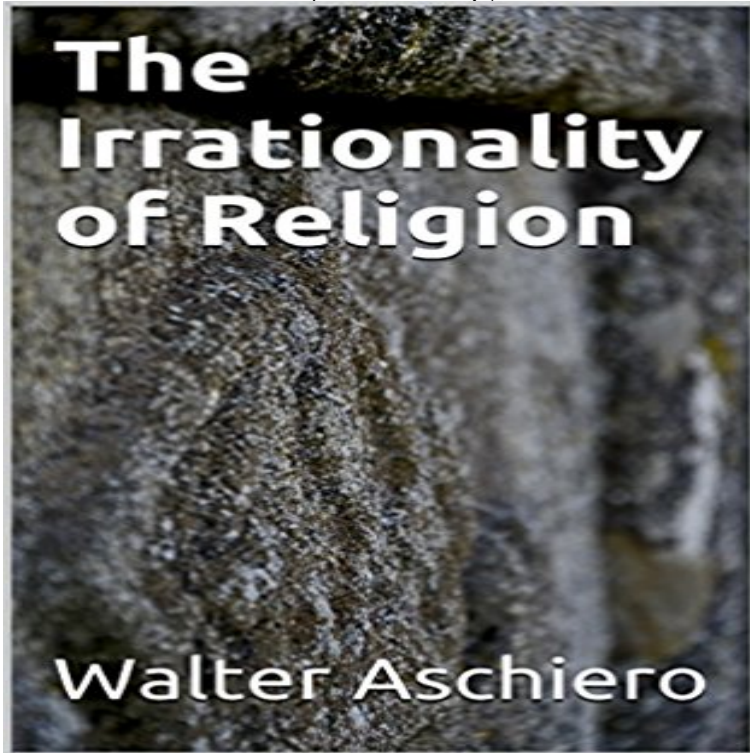


The Irrationality of Religion



The Irrationality of Religion
According to an explanation I heard while I was in college in Italy, Christianity was the creation of people who had willingly or unwillingly consumed hallucinogens, the most common one being the *Claviceps purpurea* fungus which affects many types of cereals, including rye and wheat, and from which LSD is derived.
